Teams will surf together in their own heat. Best team score wins.**

ENTRY FEE: **\$65 for surfers 40 and over (no additional entry required if already registered in the Kahuna Kupuna division and \$35 for surfers under 40 because they can only compete as part of an Intergenerational Team. Fees include entry to the Kupuna (if 40+) and Intergenerational divisions, post-contest reception, dinner and the awards ceremony.**
EQUIPMENT: **Anything that floats and can ride a wave.**

RELEASE AND HOLD HARMLESS AGREEMENT

In applying to enter this surf contest, I promise to inspect the contest site and assure myself that the area is safe for surfing, and further agree that I will not surf in the contest unless I am satisfied that the area and conditions are safe for surfing purposes. I attest that I am physically fit and have sufficiently trained for this event.

Furthermore, if I'm not feeling well in any way prior to, during, or immediately after my heat or the contest, I promise to seek medical assistance at the contest or by leaving the contest and going to a hospital or other location for medical treatment or by calling 911 or having someone else call 911 for you. After securing medical assistance and as soon as possible, we ask that you also inform contest officials of your situation (or have someone else inform us), so we can assist as needed and as possible.

I have read or will read and understand the competition rules. I will not surf in the competition area except during my own heat and will not demonstrate unsportsmanlike conduct. Any violation will be due cause for immediate disqualification. I further agree to forfeit my entry fee and points in this contest if guilty.

In consideration of your acceptance of my entry, I intend to be legally bound, hereby, for myself, my heirs, executors and administrators and hold harmless and release the Counties of San Mateo, the City of Pacifica, the State of California, their members or agents, any official/volunteer connected with this competition, and all other sponsors/supporters of this competition and everyone affiliated with Pacifica's Environmental Family, everyone associated with the documentary Surfing for Life, the Pedro Point Surf Club from all liability for injury and/or damages whatsoever, arising from my participation or presence at this competition including the post contest events.
